Tēnei Tūranga | About the role

The Senior Solicitor contributes to the operations of the Public Law team within the Legal and Privacy division. This specialist team is responsible for providing legal advice and support to the Ministry across operational advice in relation to education legislation, contracting and procurement, human rights, official information and privacy, the development of policy and legislation, the Treaty of Waitangi/te Tiriti of Waitangi, and dispute resolution and litigation.

Senior Solicitors are responsible for providing high quality, timely, accurate and practical legal advice in a complex and dynamic context and in a variety of forms, ranging from opinions to oral advice through to workshopping and training clients. They provide this support and advice to the Secretary for Education, Ministers, and the Ministry generally; to facilitate and contribute to the Ministry's goals and objectives.

The Senior Solicitor is a team member role supporting the Legal Manager – Public Law and Chief Legal Advisor, to deliver quality legal services to the Ministry and contributes to coaching and mentoring less experienced team members and delivering training to Ministry clients to develop capability.

Ngā Haepapa | Accountabilities

As a Specialist within Te Tāhuhu o te Mātauranga | the Ministry of Education you will:

- Share specialist knowledge across the organisation and with stakeholders, working with others to inform operational level decision making.
- Contribute to an effective team with a positive approach to the work environment that encourages and supports high performance, collaboration and problem solving.
- Lead the resolution of issues, identifying risks and solutions to protect and enhance the integrity and reputation of the Ministry.
- Lead or contribute to the development and implementation of innovative and fit-for purpose solutions and frameworks for current and future challenges.
- Develop and use data and insights to make evidence-based decisions and recommendations on operational issues.
- Build capability in others through coaching, quality assurance, and proactively sharing knowledge and expertise.

As the Senior Solicitor within Te Tāhuhu o te Mātauranga | the Ministry of Education, you will:

- Provide specialist expertise, skills and knowledge on legal interpretation and analysis within the Ministry's operating environment.
- Be responsible for the accurate identification and analysis of legal and other related issues and developing high quality legal advice on issues involving complexity, potential conflict, and risk.
- Lead increasingly complex and less well-defined legal assignments within the areas of expertise, skill or knowledge designated to the Senior Solicitor; including (as required) managing people and resources, and providing reports on milestones, work assignments, projects, and deliverables.
- Have deep legal knowledge and understanding in specialist area, including the ability to make strategic decisions where necessary.
- Identify trends in the relevant legal and policy environment and what this may mean for the direction of the legal advice and support to the Ministry.
- Identify and escalating risks and opportunities that may have a legal impact on the Ministry or sector, including taking a lead role in complex issues and making connections and suggestions for improvements in policies, guidelines, and legislation as appropriate.
- Challenge current thinking and support the development and delivery of a client-focused, engaged, and responsive team that understands and predicts presenting issues and identifies options and solutions that meet clients' needs.
- Effectively delegate work to others within the team and provide clear expectations.
- Work independently and provide support, mentorship and coaching to other team members as required to ensure that quality legal services are provided to the Ministry.
- Actively encourage and promote a constructive team culture of inclusion, innovation, and support.
- Review legal advice and provide quality control as needed.
- Represent the Ministry when required, including at senior official and ministerial levels, Cabinet and Select Committees.
- Proactively build and maintain effective relationships and partnerships with internal and external stakeholders, including cross organisation and sector, senior managers, Crown Law, other external legal service providers.
- Demonstrate high trust relationships with clients and proactively recognises client needs and engages accordingly.
- Be actively involved and contributing to the Government Legal Network, including practice groups.

- A proven ability to use data and insights to identify trends, risks, and opportunities, to influence and guide organisational and system-level decision making.
- Excellent interpersonal and communication skills, including proven ability to present complex legal issues clearly and concisely to a broad audience.
- Solid understanding of the New Zealand system of government, including the role of Ministers, Cabinet, Parliament and central agencies and the requirements relating to the conduct of Crown legal business.
- Solid understanding of the impact of the Treaty of Waitangi/te Tiriti o Waitangi and its principles on the Ministry's work is essential.
- Awareness of, and sensitivity to, the cultural values of different ethnic groups generally, including tangata whenua.
- A high level of integrity, self-motivation, flexibility, agility, and responsiveness.
- A high level of intellectual and analytical ability, with the ability to think strategically across a programme of work.
- A commitment to ongoing personal and professional development.
- Understands legal business and consistently operates strategically.
- Strong research, organisational, investigative, analytical, and problem-solving skills.
- Awareness of risk management and the ability to apply risk analysis to all aspects of legal work.
