Tēnei Tūranga | About the role

The Principal Cost Analyst applies their advanced technical expertise and leadership skills in developing and delivering the strategic direction of the Cost Management Initiative (CMI). This includes working closely with internal customers and suppliers for the continued delivery and success of CMI delivering high quality data driven insights.

The role is responsible for the day-to-day oversight and delivery of high-quality data for CMI, it drives progress towards a greater level of 'intelligence' related to our financial data metrics for Ministry-led capital construction projects. The primary outcome is the ability to benchmark school building construction costs and understand the trends across the Capital Works Programme.

Ngā Kōrero e pā ana ki te Tūranga

Job Description

The CMI employs a standardised approach to capture, monitor and analyse cost management data from Capital Works construction projects. This role has a critical function in capturing cost information that will be used to inform project risks, design quality, benchmarking for business case development and other analytics that will benefit the Ministry and wider construction industry.

The role connects closely with other specialists and advisors to support the overall data quality and insights of procurement systems and outcomes.

Ngā Haepapa | Accountabilities

As a Specialist within Te Tāhuhu o te Mātauranga | the Ministry of Education you will:

- Share specialist knowledge across the organisation and with stakeholders, working with others to inform decision making.
- Contribute to an effective team with a positive approach to the work environment that encourages and supports high performance, collaboration and problem solving.
- Lead the resolution of issues, identifying risks and solutions to protect and enhance the integrity and reputation of the Ministry.
- Lead or contribute to the development and implementation of innovative and fit-for purpose solutions and frameworks for current and future challenges.
- Develop and use data and insights to make evidence-based decisions and recommendations on operational issues.
- Build capability in others through coaching, quality assurance, and proactively sharing knowledge and expertise.

As the Principal Cost Analyst, you will:

- Responsible for the Cost Management Initiative, data and dashboards.
- Drives a sustainable cost management approach that captures key project construction cost data to inform business cases and understand benchmark costs across regions, project types and services.
- Manage a seconded third-party cost management company to implement the desired cost management approach.
- Provide timely insight, advice and data input into end-to-end procurement processes and informing future investment decisions.
- Support and improve the Ministry's cost management capability, in terms of data management and guidance to the business.
- Manage the construction cost databases, processes. Understand and use this data as intelligence to help inform the business
- Deliver accurate, timely and well-presented quantitative and qualitative responses to information requests. Work with our Ministry colleagues to inform qualitative responses.
- Develop the team's ability to capture, analyse and use data to drive decision making and continuous improvement across the procurement, business and budgets
- Manage the receipt and processing of construction cost information across all Capital Works projects.
- Provide periodic reporting and trend analysis against key information.
- Assist with asset management software (K2/Helios, Procurement systems) data management functions as required.

- Ensure that all appropriate processes, procedures, standards and guidelines are adhered to and adapted as necessary.
- Support Capital Works Procurement and Delivery with analysis that drives more beneficial Capital Works project outcomes.
- Make recommendations on the introduction of new tools and technologies for data collection, quality assurance and reporting

Project Management

- Establish core requirements for standardised cost management and reporting through collaboratively with external and internal stakeholders to establish.
- Lead / undertake / effectively participate in the on-going management of team or cross disciplinary projects
- Develop and lead the strategic direction of CMI across the Ministry and sector.
- Ensure external stakeholders meet key milestone timeframes as outlined in agreed delivery approach.

- Excellent relationship management skills that expertly guide internal customers in terms of discussing and confirming requirements, providing timely and accurate advice on what is possible and responding to requests.
- A basic understanding of procurement and public sector terminology and processes.
- Extensive knowledge of best practice in collection of statistical data
- Highly proficient in the use of Microsoft Excel
- Experience developing and maintaining PowerBI dashboards.
- Ability to prioritise in an environment where workloads can escalate quickly.
- A strong attention to detail with the ability to review and amend financial information.
- Ability to use technology effectively as part of daily tasks.
- Honest & Courageous - deliver the hard messages to advance the longer-term best interests of customers
- Curious - show curiosity, flexibility, and openness in analysing and integrating ideas, information, and differing perspectives; to make fit-for purpose decisions
